Tom Seymour brought the meeting to order at 6:30 pm.

Fire Dept: Chief Ford no report

Highway Dept: Dean Stevenson reported the Borough Road could use a new culvert before repaving at the washout area. They are going to repair the dump body on International. This body actually came off a retired dump truck and the salt has really deteriorated it. Dean stated that we really should be looking at new trucks because the 550 is wearing out, the piston on the dump body is failing and has had a lot of extra repairs. They had to buy a new chain saw because when they went cut a tree on Murray Hill the old one failed. Bob reminded Dean that he needs to have purchase orders approved for items over \$350.00 before he buys them because the board doesn't like surprises.

The decision was to have Starr call and cancel the work for 5/8/19 and Dean will go and review the tree in the morning.

Roofing bids for the Town Office Building – Scott Libby came Sunday and took measurements.


Called Keith McBrien on the status of the energy efficient audit and he will have information for us next week and would like to schedule a meeting.

With no further business to conduct, motion was made and unanimously approved to adjourn at 9:00 pm.


