## SELECTMEN'S MEETING

August 20, 2019

Tom Seymour brought the meeting to order at 6:30 pm.

**Fire Dept:** Chief Deanna Ford had Jeffery Ford represent her at the meeting for the 20 Shop Road issue. On a conference call it was reported that the samples came back with E-Coli and a stream of water that could be dish soap or laundry discharge. Lisa Seymour will reach out to the NH Division of Public Health Services for a more definitive answer. The Board of Selectmen have requested that everything that Dee has be brought to the Selectmen's office. Also send via e-mail the letter that will be sent to the property owner so it can be revised to include the selectmen as a contact and place on town letter head. Once completed, send a certified letter, a paper copy for the Chief and post on the house. Provide all correspondence with the Guild's per the Selectmen.

**Highway Dept:** Dean Stevenson no report

**Police Dept:** Chief Williamson reported on the Information Management System from Wolfcom Enterprise. It would include a body camera, 3 port docking station, evidence management solution software, WEMS storage solution 2TB, monitor, keyboard and mouse. This would replace the computer in the office and allow the department to have real-time information in the cruiser on patrols. The Board of Selectmen asked Chief if he had the funds in his budget to cover these expenses. Chief Williamson stated that he does the funds in his budget for this upgrade.

J. Michael Brady made a motion to move forward on the purchase of the Information Management System from Wolfcom Enterprise for \$3,200.00. Robert Dupuis seconded the motion and all were in favor.


Robert Dupuis made a motion to leave nonpublic Session and return to public session at 7:48 pm seconded by J. Michael Brady. Motion passed unanimously.

With no further business to conduct, motion was made and unanimously approved to adjourn at 8:15 pm.


