Beth Heyward and Patti Kirk from the Community Action Program (CAP) went over the various services and types of assistance CAP provides.

Paul asked how many people in Hill received assistance last yr. Beth responded that 67 people received \$31,000 in fuel assistance, 34 households received \$15,000 in electric assistance and 1 household received \$19,000 in assistance for weatherization.
