Vermont has reopened business and Jim Hall, of Dubois & King, stated that we are still on track with JP Carrier for the decking.


The Board of Selectmen reviewed the information from Mr. Herr in regards to the COVID-19 pandemic and the impact this will have on the town and its residents.

With no further business to conduct, motion was made and unanimously approved to adjourn at 7:33 pm.




