Kimberly Runion on Ferrin Street would like to but a Library Box in the small circle at the end of the street. She would maintain it with children's books, coloring books and crayons. The Board of Selectmen suggested that she places this on her property.

Open position for Highway Department -There is one applicant and they will be asked to come in for an interview.

Corrin Summers from 492 Borough Road called with concerns about her neighbor dumping sewerage on wetland land. The Board of Selectmen reviewed the email submitted by Hill Police Officer J. Woods stating that no dumping was found or being done.

With no further business to conduct, motion was made and unanimously approved to adjourn at 7:57 pm.


