MS-535 needs to be signed – completed. Lisa will upload to the Department of Revenue (DRA).


The Board of Selectmen reviewed year to date expenses to evaluate were the Town stands before the winter months.

With no further business to conduct, motion was made and unanimously approved to adjourn at 8:40 pm.


