Jeff stated it will start manually, but will not start automatically when the outage occurs. The Selectmen asked what the level of the propane tank was and when was it last filled. Jeff didn't know. He reported that calls are still down and have had about 60 calls YTD.

PUBLIC SESSION:

Bob Giuda New Hampshire State Senate for District 2 came in to discuss the impacts of the COVID-19 on the impacts for State Funding. Mr. Giuda said we might see some changes to the Highway Block Grant funding because the of the impacts of travel due to the pandemic. The Rooms and Meals tax will remain as budgeted by the state. He explained the Governor's Office for Emergency Relief & Recovery allows communities to request reimbursement for expenses related to the COVID-19 pandemic. Dave Testerman State Representative (Merrimack – District 2) came in as well to discuss the school funding bills. They both discussed the Sturgis Rally and what the effects might be here. They felt that the crowds would be minimal because of the mandatory masks for crowds over a hundred and that several restaurants in the area have chosen not to open during Bike week.

Gerry Desrochers provided an update on the elections for September. We have received the PPE from the State which includes masks, gloves, gowns, sanitizer and much more. We have Shaun Bresnahan, Russ Bailey and Randy Sanborn helping at the polls. However, we still need a Republican ballot clerk.
