

TOWN OF HILL SELECTMEN'S MEETING

April 20, 2021

Thomas Seymour brought the meeting to order at 6:00 pm.

First order of business was to make sure everyone was respecting the physical distancing and wearing masks orders issued by Governor Sununu.

Thomas Seymour made a motion to enter into Nonpublic Session at 6:00 pm seconded by Robert Dupuis. Motion passed unanimously. RSA 91-A:3, II(d).

Shaun Bresnahan made a motion to leave nonpublic Session and return to public session at 6:30 pm seconded by Robert Dupuis. Motion passed unanimously.

Robert Dupuis made a motion to enter into Nonpublic Session at 7:27 pm seconded by Shaun Bresnahan. Motion passed unanimously. RSA 91-A:3, II(a).

Robert Dupuis made a motion to leave nonpublic Session and return to public session at 7:49 pm seconded by Thomas Seymour. Motion passed unanimously. Motion made seal the minutes passed unanimously.

Jeff Ford called at 7:53 pm to say that Dee is done because you fired her. Lisa Seymour told Jeff she was going to place you on speaker phone. In the room was Thomas Seymour, Chairman, Robert Dupuis and Shaun Bresnahan. Lisa asked Jeff to please tell the board what you said to me. Jeff said that Dee was done because we fired her. Shaun Bresnahan corrected Jeff as we didn't fire her, we simply asked for her resignation.

Actions needed to take in light of Dee's resignation are:

- Confer with Town Council.
- Set-up a special meeting with the Fire Department.
- Request all property be returned to the town.
- Lisa Seymour will reach out to Advance Lock & Alarm to have the locks changed and possibly have a fob system install which would connect with the current system at the town office.

Thomas Seymour made a motion to send the response to Charles Estes' complaint on Murray Hill Road. Robert Dupuis seconded the motion. All in favor.

Robert Helmers plans to have the maps in the office next week.

Robert Dupuis made a motion to have Shaun Bresnahan review the current building permit and update. Seconded by Thomas Seymour. All in favor. This will entail reaching out to both the Planning Board and Zoning Board for suggestions as well.

The question of who can issue fire permits was addressed. This takes training to be able to issue them. The Selectmens Office use to issue them, but now there is no one trained to do it.

Shaun Bresnahan asked if it would be a conflict if he still did the mowing at the pump house on Murray Hill Road. Lisa Seymour will check with the auditors to see if it would be.

Shaun Bresnahan asked about the mask requirements since the governor has removed the mask required order. The Board has decided to make it a recommendation only for the Town Office Building to wear masks going forward. Lisa Seymour will reach out the Library Trustees to let them know.

Thomas Seymour asked about when we could implement the bi-weekly payroll for the employees. We need to send a memo to the employees to let know this will be happening.


Robert Dupuis made the motion to adjourn the meeting. Shaun Bresnahan seconded the motion. All in favor
