SELECTMEN'S WORKSHOP December 28, 2021

Thomas Seymour brought the meeting to order at 6:02 pm.

Board Business:

Thomas Seymour made a motion to enter Nonpublic Session at 6:03 pm seconded by Shaun Bresnahan. Motion passed unanimously. (RSA 91-A:3, II(a))

Thomas Seymour made a motion to leave nonpublic Session and return to public session at 7:02 pm seconded by Christopher Gronski. Motion passed unanimously. Motion made to seal the minutes passed unanimously.

Thomas Seymour made a motion to enter Nonpublic Session at 7:03 pm seconded by Shaun Bresnahan. Motion passed unanimously. (RSA 91-A:3, II(b))

Christopher Gronski made a motion to leave nonpublic Session and return to public session at 7:41 pm seconded by Shaun Bresnahan. Motion passed unanimously. Motion made to seal the minutes passed unanimously.

Business Meeting:

The Board of Selectmen discussed the expenses related to the removal of the sidewalks on the North End of Mountain View Drive and decided to have the materials for the project come from the Sidewalk Expendable Trust Funds.

Shaun Bresnahan made a motion to remove \$2,076.00 from the Sidewalk Expendable Trust Funds for the loam used on the Mountain View Drive sidewalk removal. The Selectmen are agents to expend from this fund. Christopher Gronski seconded the motion. All in favor.

Shaun Bresnahan is going to tell David Thomson that the Board of Selectmen prefers to not write the warrant article to remove the Sidewalk Expendable Trust Fund because this was a petition warrant article submitted in 2019 by the taxpayers. David Thomson (or someone else) would need to obtain the 25 registered voter signatures.

Shaun Bresnahan said he would propose we having a warrant article to remove the South End of Mountain View Drive with expenses paid from Sidewalk Expendable Trust. Without having a reasonable estimate for expense, we could propose 40K and have 20K come from the Sidewalk Expandable Trust Fund and up to 20K to be raised by taxation. Shaun will work on estimate. He hopes this will get a good conversation on what direction we take on sidewalks.

Christopher Gronski is going to compose a letter to remove the clause about taking the vaccine out of the ARPA Grant funding program before he will sign it.

Shaun Bresnahan made a motion to enter Nonpublic Session at 8:04 pm seconded by Christopher Gronski. Motion passed unanimously. (RSA 91-A:3, II(c))

Shaun Bresnahan made a motion to leave nonpublic Session and return to public session at 8:15 pm seconded by Thomas Seymour. Motion passed unanimously. Motion made to seal the minutes passed unanimously.

With no further business to conduct, Shaun Bresnahan made the motion to adjourn the meeting. Christopher Gronski seconded the motion. Motion passed unanimously motion at 8:29 pm.
