

Water Commissioner Meeting

October 11, 2022

Commissioners Present: Tom Seymour, Shaun Bresnahan, Frank Razzaboni & Lisa Seymour (Secretary)

Commissioners Absent: None

Public: Jamie Moulton and Brian Vose

Tom Seymour brought the meeting to order at 6:30 pm.

Commissioner Business:

The fire hydrant flushing has been completed and there is one hydrant near 61 Crescent Street that is out of commission. SKR will look into this to see if it needs to be replaced or repaired, we already have the parts here. A number of the gate valves that isolate each hydrant are not in operation because they have sediment in them. Danny Woodhams said they can use a compressor to blow the sediment out.

Shaun Bresnahan and Danny Woodhams from SKR worked on the repairs to 12 Quimby Road. The water pressure is better to the house but still low inside the house. Danny said because it's at the end of a line and it gets a lot of sand and silt so a blowout line was installed.

Brian Vose, GIS Specialist from Granite State Rural, came to review the mapping that was done with Gerard Desrochers (former Water Commissioner). They had started drafting the Town of Hill Water Distribution Network. The map consists of Hydrant, Gate Valves, Curb Stops, Blow-off Valve, Enclosed Storage Facility, Meter Station, Production Well, Pump Station, Water Main, Service Line and Structure. The Water Commissioners asked if this was something that they would be able to finish. Brian Vose said that the grant has closed so we would need to look into another funding source to continue the mapping. Brian suggested using Diamond Maps to access and use GIS data; they are a cloud-based GIS design company.

The warrant was signed to create and issue the monthly water bills.

John Benham from Pump System has been servicing the water system chemicals and monitoring for high PH & chlorine levels for over 15 years. John did express that the chart recorder is out of date and difficult to find parts to make repairs. John Benham is looking into pricing for a cloud base system which would require internet service. Lisa Seymour has received quotes from Comcast and Consolidated Communications. The Water Commissioners will be meeting with John Benham from Pump Systems on October 25th at their location.

The Commissioners discussed installing a generator at the pump house.


The water commissioners will be meeting the 2nd Tuesday of the month at 6:30 in the Selectmen's Office.
