Town report write-up & Dedication:

Tom Seymour will work on the report for the Town Report. The Board of Selectmen will be dedicating the Town Report to Linda Denningham. Lisa Seymour will reach out Charles Denningham. Linda Denningham was very involved in the Hill Post Office.

The tax rate was set on November 10th by the Board of Selectmen and submitted to the NH Department of Revenue. Because of a discrepancy in the reporting of the school adequacy grant funding the Town tax rate is on hold and needs to be reset.

The town has received a generous donation of Gift Cards from The Manolis Family Foundation Inc. "Project Helping Hands". They have asked the Selectmen to distribute to those in need and they will be delivering these for the Thanksgiving Day Holiday.

In the November 1st meeting Tom Seymour made a motion to stay with the current health insurance policy and Frank Razzaboni seconded the motion. The information was submitted to HealthTrust to finalize the rates. HealthTrust Insurance Policy for 2023 has been signed.

Lisa Seymour will be sending a letter to 248 NH Route 3A regarding the haunted house remnants not being cleared and other debris.

Stephen Thomson inquired if the Selectmen had a chance to review the RSA Merker August Special Exception. The Board of Selectmen did review. However, the decision reached remains the same.

Stephen Thomson inquired about the three buildings on 318 Cass Mill Road. This property was subdivided earlier this year with the intent to have a new home built on the larger lot. Frank Razzaboni will check the property.

Stephen Thomson inquired about having the Special Exception and Variance form amended to add abutters list required upon submission. The rules of procedures Town of Hill Board of Adjustment under section **VII Application, Hearings & Decisions** Section A (5) Every application shall be accompanied by a current list of abutters complete with mailing addresses. Stephen asked the Selectmen to look into changing the form.

With no further business to conduct, Francis Razzaboni made the motion to adjourn the meeting and Thomas Seymour seconded the motion. Motion passed unanimously motion at 7:55 pm.
