January 7, 2025

Shaun Bresnahan brought the meeting to order at 6:30 pm.

# **Highway Department:**

Gregg talked to Mike Corliss about being a back-up driver during snow storms if we had an employee out. Mike Corliss filled out an application and no the Selectmen would like to talk with him and see if he is still interested. Shaun will reach out to see if he could meet on Friday January 10<sup>th</sup>.

Stephen asked how the equipment is holding together? Tony things are holding together. We need to order a fuel pump for the loader, window washer for the trucks and oil. Shaun Bresnahan in the interim we can have Tony purchasing the items need to keep the equipment running.

The front axel on the 6500 needs replacing plus the bearings. The International still has low power and we are still trouble shooting the issue. Tony said that the truck has 94K miles. The 6500has a broken left rear spring. Shaun Bresnahan asked Tony to call around for quotes.

Salt pile looks good and the sand at the town shed is good. The sand at the Clough pit is getting low.

## Town Clerk:

Shelly Henry reported that candidacy sign up starts January 22<sup>nd</sup> to January 31<sup>st</sup>. Shelly asked the board should just post the elected position or included the appointed positions as well. Stephen Thomson do both and maybe that will get people interested in joining boards. Shelly is looking for someone to cover the vacancy on the Supervisor of Checklist.

Shelly inquired about the giving tree this year. Shaun Bresnahan mentioned that there will be changes to the process next year because it wasn't handled correctly. Stephen Thomson asked about the issues with the giving tree? The issue is the presents were not all delivered by Christmas. This will be discussed further before the program starts this year.

There was a question about the Hill Fire Association and the transparency of their meetings. Because this is a 501 C 3 non-profit and registered with the Attorney General it should be transparent with meeting minutes.

#### Public:

Shaun Bresnahan will look at this tomorrow and develop a plan of action. James Moses is interested in purchasing the tract of Town property however, this needs to go before Town Meeting.

Tony Cartier will be filling in at the Transfer Station when someone is out. He will be covering for Paul Burnor in January and will apprentice under Anson Libby. Tony will be compensated at his current rate at the Highway Department. Tony inquired if he take the hours worked at the Transfer Station as comp time. Lisa Seymour will check the NH Labor Laws to see if this can be done.

Tom Scribner said that when he was going to do the bluegrass festival, he spoke with the manager at the TD Bank about donations. Shaun Bresnahan asked if Tom had a contact number or person.

Michael Wallace asked if a letter could be sent to Bruce Blazon regarding the lights shining onto his property. Mike is also concerned with smoke that is coming onto his property because it appears that he is burning trash. Mike has a concern about a gravel pit on his property. Shaun Bresnahan said a landowner can excavate on there property as long as it is for there personal use and not in current use.

The new LED motion lights have been installed in the hallway at the Town Office.

Paul Guild provided an update on the Fire Committee – draft has been completed and email for review and should be approved on January 13<sup>th</sup> and ready to submit to the Selectmen on January 14<sup>th</sup>
