- 5. Ron Bryson sent email for release of deed on Range 17 Lot 0B 3 persons to go from his mother (Wendy)who is not buried in Pleasant Hill to his sister Kelly L. Bryson.
 Call to be made to Ron Bryson concerning burials P.R. to do <u>Completed</u>
 Burial was on Oct 14, 2025. Mr. and Mrs. Bryson also purchased a new stone and had the old one removed. One name (Wendy) on the stone is in memory only with no actual burial. The Bryson's complimented us for helping to facilitate the burial, they were very pleased with the communications.

NEW BUSINESS

1.The Pleasant Hill Cemetery Association has been legally dissolved with the guidance and approval of the Attorney Generals of NH office. The Nellie Rounds flower fund (\$1415.88)

has been successfully closed and the money turned over to the Trustee of the Trust Fund of Hill NH. Plus, the checking account for the Pleasant Hill Cemetery Association (\$8765.21) has been successfully closed and turned over to the town for the general funds account. Again, each of these was done with the guidance and approval of the office of the Attorney General of NH. A copy of Nellie Rounds will has been found. The selectmen and the trustees of the trust have received copies. Also, a copy of the will has been sent to Amy Nichols at the Attorney General's office.

- 2. This year (2025) has seen 2 burials in Bunker Hill, 1 in Murray Hill/Dickerson, and 4 in Pleasant Hill. While 2 lots have been sold in Pleasant Hill.
- 3. Information has been sent to M. Fuller for her cremains burial in the future in the Robie lot. Div N Range 3. Her mother and stepfather, ½ brother and sister-in-law are in said lot.
- 4. The Wells Cemetery on Currier Road has been found. There appears to be four broken stones, however the names if there were any, do not show. An old town record made in 1983 states "Wells, Unreadable first name, wife of Philip" death date of 1832. We should have sign made and put in place designating the spot the Wells Cemetery is located.

A citizen of the town has volunteered to make a Wells Cemetery sign in the same style as existing ones in other town of Hill cemeteries. Vote: All in favor to accept the offer, none against.

- 5. A notice needs to be put posted that the Pleasant Hill Cemetery is closed for burials as of November 1, 2025. Sent out in the town wide email on November 6, 2025 **Completed**
- 6. Cemetery grass cutting contract needs to be sure that it list bagging of the clippings. Ask town to do this. As the town receives all contracts and sign/pays same (request in writing delivered to town)
